**Nina Półtorak** Professor of EU law at the Jagiellonian University, Judge at the General Court of the European Union since 2016; Director of Postgraduate Study Programmes in EU law at the Jagiellonian University (2006-13); Visiting scholar at the University of Oxford (1998) and visiting fellow at the European University Institute, Florence (2005); admitted to the Kraków Bar (2000); legal counsel (2000-12); Judge at the Regional Administrative Court, Kraków (2012-16); seconded to the Supreme Administrative Court of the Republic of Poland (2014-16); Director of the EU Law Department, Supreme Administrative Court

(2013-16). Author of numerous publications on European law and judicial protection.



**Tomasz Tadeusz Koncewicz** Professor of EU Law; Director of the Department of European and Comparative Law, University of Gdańsk; Member of the Editorial Board of the Oxford Encyclopedia of EU Law; Member of the Council of the Fondation Jean Monnet pour L'Europe in Lausanne; Attorney specializing in the strategic litigation before supranational and constitutional courts; Principal Investigator at Paneuropean research projects: H2020 Reconciling

**Oleh Petryshyn**, PhD in Law, Senior Researcher, Academic Secretary of the SRI of State Building and Local Government of the NALS of Ukraine. He is a dedicated legal scholar with over a decade of research experience and over seven years of academic teaching expertise, holding a Doctorate in Law and currently serving as a Senior Researcher. His research interests focus on European law, the law of the European Union, human and civil rights at national and local levels, rights of internally displaced persons, and maintaining the rule of law and constitutional governance during

martial law conditions in Ukraine. He has contributed to numerous publications in Scopus and Web of Science indexed journals, serves as a collaborating reviewer, and received the 2021 scholarship commemorating the Revolution of Dignity and the Heroes of the Heavenly Hundred.



**Piotr Bogdanowicz**, Professor of EU law at the University of Warsaw Faculty of Law and Administration, where he lectures on EU law, including EU public procurement law. He is an author of several books (the most recent one on contract modifications in EU procurement law) and articles in leading journals, including "Common Market Law Review", "Public Procurement Law Review" and "European Procurement & Public Private Partnership Law Review". in public procurement law. He is a former adviser to the Polish Constitutional Court.
