ABOUT GUEST SPEAKERS



Leszek Garlicki is a Visiting Professor of Law at the Washington University in St. Louis. Since 1968 he has worked at the Warsaw University (since 1987 as full professor), in the years 1980-1993 was member of the Warsaw bar, in the years 1993-2001 judge of the Constitutional Court of Poland and in the years 2002-2012 judge of the European Court of Human Right (president of the 4th Section in 2011-2012). He served recently, as visiting professor, at the Tel Aviv University, Hong Kong University, New York University, and at Yale. Judge Garlicki is vice-president of the International Association of Constitutional Law and one of the Founding Members of the European Law Institute. He lectured at numerous universities in Europe, the United States, Israel, Japan, China, and Hong Kong. He is author or editor of over 300

publications in different languages, including a five-volume Commentary to the 1997 Constitution of Poland and two-volume Commentary to the European Convention on Human Rights.



Matthias Hartwig studied law in Erlangen, Aix-en-Provence and Freiburg. He defended PhD thesis in international law and now is a Researcher at the Max Planck Institute for Comparative Public Law and International Law in Heidelberg, Germany. Dr Hartwig worked as an Assistant at the Federal Constitutional Court of Germany and the Corte costituzionale of Italy. He was lecturer at the University of Heidelberg, Saarbrücken, Trento/Italy, Santiago de Chile, Al Fahrabi University of Alamaty, Universidad del Rosario/Bogotà, Colombia, Hobart/Australia. Dr Hartwig has served as legal counciling at various constitutional courts in Eastern Europe, among others in Russia, Latvia and since 1997 in Ukraine, councelling in the constitution drafting

processes in Libya and Yemen. He has published numerous publications in international law, European law, and constitutional law.



Marta Kłopocka-Jasińska, PhD in Law, works as an Assistant Professor at the Chair of Constitutional Law, Faculty of Law, Administration and Economics, University of Wroclaw (Poland). She participated both as a leader and a member of research team in national and international projects, including "Constitutional complaint against judicial decision the model suitable for Poland", funded by the Polish National Research Centre (2014-2020). Her main areas of research are human rights protection systems, comparative constitutional law, and the judiciary. She has given numerous lectures and courses at national and

international level and has carried out several research stays, among others: Complutense University of Madrid, Max Planck Institute for Comparative Public Law and International Law (Heidelberg), Centre for Political and Constitutional Studies (Madrid), European Court of Human Rights, Constitutional Court of Spain and Constitutional Tribunal of Poland. She is a Member of the Wroclaw Bar Association.

Volodymyr Venher, Dean and Associate Professor of Constitutional Law of the Faculty of Law at National University of Kyiv-Mohyla Academy, former Deputy Head of the Secretariat of the Constitutional Court of Ukraine (2017-2018) and Head of the Secretariat of the Parliamentary Committee on Legal Policy and Justice (2014-2017). He holds a degree of Candidate of Science of Law (PhD), conducts comprehensive research on theoretical foundations and practice of

implementation of the rule of law and human rights standards in Ukraine. His research activities are aimed at developing and substantiating methods for applying performance criteria for public authorities in various areas: provision of public services, organization and conduct of elections, judicial control over the protection of human rights.
